**9:00 a.m. until noon\*\*Please note that students will need to attend all three days.\*\***

All parents will be responsible for contacting Bob Jones University (BJU) and ordering their children's tests. Our **deadline for ordering tests will be March 10, 2009**. Any order received by BJU after this date will have a \$30 rush fee applied to each order. Please mark your calendar now. The price of the tests is as follows:

**If ordered in January.....\$40.00 each**  
**If ordered in February.....\$37.40 each**  
**If ordered in March prior to the 10th.....\$39.60 each**

\*\*The price in the catalogue may be \$44, but the above prices are an unadvertised special.\*\*
